- January 1 2018 SGER (Specified Gas Emitters Regulation) – increased to \$20 per tonne
- o These increases also set in motion the \$2B PPA debacle that continues to affect electricity prices
- SGER increased to \$30 per tonne
 CCIR replaced SGER, remaining at \$30 per tonne but changing from a facility specific model to an output based allocation model in Budget 2017
