# UCP Board of Directors Election 2023 FAQ and Instruction Sheet

#### **Eligibility (section 4 of the Rules)**

To stand for election, an individual must:

- Be a current Member of the UCP.
- Have registered to attend the 2023 AGM.
- Submit a complete Application package before the application deadline.
- Pursuant to the UCP Bylaws, if seeking election as director for one of the five regions, the individual MUST ordinarily reside in the region in which they are seeking election.

#### A full and complete application includes:

- 1. A complete UCP Board of Directors Election Application (Schedule B).
- 2. A \$250 compliance bond paid by cheque or e-transfer. If paying by e-transfer, confirmation of the e-transfer must be submitted along with your application.
- 3. A complete Board of Directors Nomination Petition with 25 valid signatures from current UCP Members (Schedule C).
- 4. A signed Board of Directors Confidentiality Agreement and Declaration (Schedule D).
- 5. A signed Board of Directors Statutory Declaration for Use of Membership List Part A (Schedule G).

### **Frequently Asked Questions**

#### What positions are available?

Pursuant to Article 7 of the UCP Bylaws, the following positions are open:

- President
- Secretary
- Vice President (Communications)
- Vice President (Fundraising)
- 5 directors 1 from each of the following regions Calgary, northern Alberta outside of Edmonton, Edmonton, central Alberta, and southern Alberta outside of Calgary.

A description of the constituencies that comprise the 5 regions is Schedule A of the Board of Directors Application Package. Please review the document carefully to ensure you meet the residency requirements if seeking a regional director position.

#### • When is the application deadline?

Applications must be submitted no later than 5pm Mountain Time on **October 2**, **2023**

# Can I get a copy of the membership list to obtain signatures?

No. The party will provide a copy of the list of Members who have registered for the AGM no later than Monday, October 16, 2023.

# • I live in Beaumont. Can I seek election for the Edmonton regional director position?

No, a person must ordinarily reside in the region in which they are seeking election. The town of Beaumont is in the constituency of Leduc-Beaumont, which is in the Central Alberta region.

# • Is there a residency requirement for President, Secretary, or the Vice President positions?

No. As long as you are a member of the UCP and have registered to attend the AGM, you may submit an application for these positions.

## • Who can sign the nomination petition?

Any current Member of the UCP can sign a nomination petition. Additionally:

- Members can sign more than one candidate's nomination petition.
- o A candidate can sign their own nomination petition.
- The nomination petition can be signed electronically
- Can I use the party logo on my campaign materials?

# • When is voting?

Voting for the Board of Directors Election will take place solely at the 2023 UCP AGM in Calgary.
